OFFICE-ORDER

Pratapgarh (Rajasthan)**, in Chittorgarh-Pratapgarh Lok Sabha Constituency is one of the 50 new Kendriya Vidyalayas sanctioned.

Since the land in the matter of this Kendriya Vidyalaya has been transferred by the District Administration in favour of Kendriya Vidyalaya concerned, sanction of the Commissioner, KVS is hereby conveyed to start a new Kendriya Vidyalaya under Civil Sector with immediate effect, at the following location:-
